If they do touch their faces when training, we will ask them to sanitise their hands. Hand hygiene will be enforced. Everyone entering the building will have to sanitise their hands before entering the gym hall. We will introduce additional hand hygiene during the session. Vault fitted with a Covid 19 Safety Cover and cleaned accordingly. Safety mats blocks etc. will be sanitised after use.				The hazard is controlled as far as reasonably practical

Covid 19 being spread from bodily fluids such as urine and blood.	Everyone in the gym	If an accident has taken place, the area is to be cleared. The first aider is to ensure that they use barrier gloves and if CPR is needed the current British Heart Foundation guidance is followed. If the first aider feels at risk, they are at liberty to refuse to administer first aid. Where possible the casualty is to be instructed to self-treat, i.e. hold this bandage here and lift your arm. Therefore, the first aider does not come into contact with blood. Fire emergency causing social distancing to be compromised. Potentially resulting in Covid 19 being spread	Everyone in the gym	If the fire alarm is sounded, we will evacuate the building maintaining a 1+ distancing if it safe to do so. If fire or smoke are seen or felt the building will be evacuated as quickly as possible regardless of social distancing. The consequences of fire outweighs the potential harm Covid 19 might do. Once the gym has been cleared social distancing will be maintained at the assembly point. If social distancing has been compromised those who have been involved are to be segregated from those who were able to evacuate while observing social distancing. It is likely that if someone has been in a fire and seen the fire or smelt smoke that they will need medical screening by the ambulance service even if they are not admitted to hospital.	5	1	LOW	The hazard is controlled as is reasonably practical
